TRANSFORMING LIVES

When I was seventeen, I became homeless. My home life had deteriorated to the point where my safety and support were no longer possible. My family was in crisis. I had to leave.

I was desperate, alone, scared and vulnerable. A friend helped me find a shelter that would take me in. We searched the yellow pages and found a YWCA Toronto women's shelter, and I called. It was 11p.m. and they had room. That was the beginning of hope for me.

For many years I wanted to have the opportunity to help teenage girls faced with homelessness,

in the same way that I was helped years before. When I began to think about my legacy, I realized that leaving a bequest to YWCA Toronto would be my opportunity to do exactly that.
